EXECUTIVE SUMMARY

The Pesticides and Toxic Chemicals Control Board (PTCCB), a semi-autonomous Agency within the Ministry of Agriculture operates under the Pesticides and Toxic Chemicals Control Act 2000 (No. 13 of 2000). Its principle function is the management of pesticides and toxic chemicals with specific focus on the manufacturing, importation, transport, storage, selling, using and advertising of these chemicals in Guyana.

PTCCB is operated by its permanent Secretariat which carries out the mandatory responsibilities and the operational and administrative policies handed down by the Board of Directors.

During the year under review, the PTCCB was involved with a wide range of pertinent activities which were all integrally linked to the principal responsibilities.

The key areas of activity of the PTCCB during the year 2014 were as follows:-

- General Administration
- Inspection and Enforcement
- Registration and Licensing
- Quality Control
- Training
- Internal Capacity Building
- Overseas Participation
- Analytical Testing
- Monitoring and Evaluation
- Public Awareness
- International Cooperation Conventions and Instruments

Details pertaining to these activities are documented individually in the body of this Annual Report.

This Report demonstrates comprehensively that the PTCCB continued to carry out its mandate, as it had done over the years since its establishment, in a proactive manner in partnership with the Ministry of Agriculture, sister Agencies, and representatives of the Private Sector, Pesticides Stakeholders and relevant overseas based organizations.

Importantly, strong emphasis was placed on interactive sessions with importers, manufacturers, traders, farmers and other end users of chemicals in Guyana. The goal of sound chemicals management for Guyana has been the driving force to a chemicals management plan that is country focused, stakeholder driven and widespread in its target.

The PTCCB remains committed to carrying out its mandatory responsibilities during the year 2015 with specific focus being placed on strengthening chemicals management through (i) Enforcement of Regulations (No. 8 of 2004) and (ii) Providing the necessary infrastructure required for the establishment of appropriate educational, advisory, and extension services for enabling and exercising adequate control over quality, sale, storage, import, distribution and usage of pesticides, while ensuring that the interest of end-users and importers' rights are well protected.

The Board additionally through the Strategic Approach to International Chemicals Management, the Rotterdam and Stockholm Conventions and in collaboration with other International Chemicals Management Instruments will be meeting the obligations as it relates to a lifecycle approach to chemicals management.

INTRODUCTION

This Report documents the activities of the Pesticides and Toxic Chemicals Control Board (PTCCB) for the year 2014. It highlights the accomplishments and discusses constraints associated with the Board's objectives with respect to activities initiated during the year under review. The Report highlights the tools utilized towards achieving sound chemicals management identify gaps and mechanisms implemented so as to address all aspects of chemicals management in Guyana.

Ms. Trecia David - Registrar of Pesticides and Toxic Chemicals continued to function in the capacity of Secretary to the Board in accordance with the relevant provisions enshrined in the Pesticides and Toxic Chemicals Control Act 2000 (No. 13 of 2000).

Meetings of the Board

Statutory Meetings of the Board were scheduled to be held on the last Wednesday of every month; nine such meetings were held. The punctuality of the Members in attendance at the Meetings was exceptional throughout the year.

Arrangements were in place for the conduct of technical meetings during the period under review as might have been necessary. Technical committees were established to address the following:

- a) Radioactive substances
- This technical committee was established to examine current management of radioactive material in Guyana throughout its lifecycle and the role of the Board with regards to same. The findings reveal that the Ministry of Health in collaboration with the Environmental Protection Agency currently manages radioactive materials in Guyana. The Board participated in a meeting of key stakeholders to discuss to development of a regulatory instrument for radioactive mechanism.
- b) Fumigation practices in the rice industry
- The Board in collaboration with the Guyana Rice Development Board and the National Plant Protection Organization examined fumigation practices in Guyana with specific focus on the rice industry. This process has identified specific gaps that are to be address through an inter-agency collaboration in 2015.
- c) Preparation of Guidelines for Aerial Application of Pesticides
- Draft guidelines for aerial application of pesticides were developed and are currently being finalized for distribution to relevant stakeholders.

Responsibilities of the Board

The Board is charged with the responsibilities for making arrangements and providing facilities for controlling the manufacture, importation, transport, storage, selling, using and advertising of pesticides and toxic chemicals in Guyana.

Objectives of the Board

The primary objective of the Board is to fulfill its mandate under the Pesticides and Toxic Chemicals Control Act 2000 (No. 13 of 2000) and its associated Regulations. The Board in an effort to ensure effective and efficient functionality invested in capacity building to allow for the relevant technical expertise to enhance these specific areas.

It was also the Board's objective to develop effective and workable criteria and protocols to be used to achieve the target goals with the minimum displacement of production or trade and to collaborate with the pertinent stakeholders in helping them to achieve their respective and collective economic targets with minimal negative impact to human health and the ecosystem.

The specific objectives of the Board for the year under review were as follows:

- Fulfilling the International Requirement of the Board for the Rotterdam and Stockholm (i) Conventions;
- (ii) Registration and Licensing of Pesticides;
- Licensing of Vendors; (iii)

SECRETARIAT OF THE BOARD

Organizational Chart

The organizational chart of the Board contains four divisions: Licensing and Registration, Enforcement and Training, Administration and Analytical Department. The total staff compliment of the Board during the period under review is thirteen (13).

General Administration

The implementation of the policies of the Board is carried out by an adequately staffed Secretariat located at the compound of the National Agricultural Research and Extension Institute, Mon Repos, East Coast Demerara. This Secretariat, which is headed by the Registrar holds responsibility for General Administration and Operations including (i) training and (ii) enforcement of the rules and regulations associated with the manufacture, importation, transport, storage, selling, using and advertising of pesticides and toxic chemicals in Guyana.

Staff Development

Throughout the period under review the Board, in recognition of the need for capacity building towards facilitating the provision of services to farmers and other stakeholders allowed staff to participate in a number of training exercises conducted by other Agencies and International stakeholders (See Appendix 1).

ACHIEVEMENTS - 2014

The Pesticides and Toxic Chemicals Control Board's is pleased to present the major achievements of the Board for the period under review.

1. Registration and Licensing

Pesticides Submitted For Registration

The Board received fifty two (52) applications for registration during the period under review. These products were evaluated to ensure that submissions were in keeping with the Regulation before registration. Phostoxin, with registration number PTCCB/DEG/I/08/001 was de-registered in 2014, in keeping with Regulations registration period of 5 years. In addition, there was no request from the manufacturer/registrant for re-registration.

A total of 293 products were registered at the end of 2014 for import, distribution and use in Guyana. The List of Registered Pesticides for Guyana is updated annually and is printed for free distribution (see Appendix II).

The Board issued One thousand, Seven Hundred and Twenty Five (1725) Pesticides and Toxic Chemicals licenses for the period under review. The following table presents a breakdown of all licenses issued for Pesticides and Toxic Chemicals for the period under review. *Appendix III* presents the analysis of all pesticides imported for 2014.

Importers of Pesticides

The Board in keeping with its mandate to raise awareness to all stakeholder groups conducted its annual meeting with all the *Pesticide Importers* in Guyana. The meeting outlined the achievements of the Board for the year 2013 and highlighted the new developments and initiatives in pesticides related matters at the international, regional and local level.

Pest Control Operators Registration

The Board in keeping with the Regulations registered a total of 18 Pest Control Operators for the year under review. Training was also provided to all Pest Control Operators at the Basic and Intermediate Proficiency Levels.

The Board's annual meeting with all the registered Pest Control Operators (PCOs) outlined the plans of the Board in relation to activities that will benefit the PCOs such as licensing, training and certification. The PCOs were given the opportunity to highlight matters of concern to them in which they emphasized the need for the Board to enforce the regulation to combat the illegal operations by persons in this discipline.

Vending Premises Licensed 2014

A total of one hundred and seventy nine (179) pesticides vendors were registered to handle, store and distribute pesticides in Guyana. This is in keeping with the Board's mandate in ensuring sound chemicals management in Guyana. Stakeholder meetings and trainings were undertaken during the year in review so as to ensure vendors are knowledgeable and well equipped to work with pesticides. A summary of pesticide vendors can be viewed in *Appendix IV*.

2. Inspection and Enforcement

All registered vending sites were inspected during the year in review and were found to be in compliance with the Pesticides and Toxic Chemicals Control Act 2000. Random Inspections were also conducted in regions 2,3,4,5,6 and 10 on various locations and market places that were identified through intelligence gatherings.

Inspections were also conducted at all operating sites of Pest Control Operators (PCOs). All PCOs were found to be in compliance with the PTCCB Regulations.

Inspection exercises were also carried out at various ports of entry and shipments of pesticides imported into Guyana. These inspections ensured that all pesticides imported are registered for import and use in Guyana.

The Board acting on intelligence confiscated 26 cartons containing 10 (1kg) canisters of unregistered Aluminium Phosphide each (260 canisters) from a private residence in Houston E.B.D.

"Carbon tablet", as it is commonly called in Guyana, is a lethal material that releases the highly toxic phosphine gas. This product which is mainly marketed as "Phostoxin" contains "aluminum phosphide" which came into use in the 1950s and is destructive to many storage pests. Phosphine gas is notoriously lethal; it is a fast acting, systemic, and corrosive killer. Any use of this product by householders or anyone not qualified to do so can result in accidental poisoning and death. It is a controlled pesticide that should only be handled by professional pest control operators (PCOs).

3. Training and Awareness Programmes

Symposium on International Conventions and Chemical Agreements

The PTCCB launched its public awareness programme in 2014 with a symposium on International Conventions and Instruments in chemicals management at the De Impeccable Banquet Hall, Georgetown. This symposium was geared at sensitizing technical personnel of various Ministries and NGO's with the objectives being:

- 1. Raising awareness about the various International Chemical Agreements
- 2. Highlighting the impact of these Agreements on Chemicals management at the National Level
- 3. Highlighting specific goals achieved at the national level via International Chemical Agreements
- 4. Enhancing stakeholder participation and information sharing mechanisms for chemicals management in Guyana.

The Symposium facilitated presentations on the following Chemical Agreements:

- a. Stockholm Convention
- b. Rotterdam Convention
- c. Strategic Approach to International Chemicals Management
- d. Coordinating Group of Pesticides Control Board
- e. Basel Convention
- f. Montreal Protocol

The Symposium was executed in collaboration with other agencies and Ministries, as part of the Board strategy to bolster stakeholder, inter-agency and inter-ministerial participation in its awareness strategy.

Safety and Health in the Use of Chemicals at Work

The PTCCB actively participated at the Occupational Safety and Health Ceremony and Symposium hosted by the Ministry of Labour. The Chairman, Registrar and Senior Inspector of the Board engaged in a panel discussion with participants at the Symposium on the Safety and Health in the Use of Chemicals at Work. The Board also delivered a Power Point presentation on chemicals and chemicals management in Guyana.

Safe Storage of Pesticides

The Board launched a pilot project aimed at raising awareness on proper pesticides storage in Cane Grove, Mahaica. The event commenced the programme for a countrywide distribution of pesticide storage cabinet to farmers using a lottery system for distribution. The aim of this exercise was to promote proper and safe storage of pesticides with the view of farmers throughout the country adopting this practice. A total of 150 cabinets were distributed to farmers in regions 2,3,4,5,6 and 10.

Pest Control Operations Training Programmes

The Basic Proficiency Training programme for Commercial Pest Control Operators now in its third year saw the certification of 28 pest control applicators for the urban and domestic pest control. The aim of the training was to impart knowledge and education to pest control applicators in conducting pest control operations with the ultimate goal of solving the pest's problem and at the same time minimize the negative impacts to human health and the environment cause by pesticides.

The Intermediate Proficiency Training programme for Commercial Pest Control Operators was held for the first time in 2014. Participants qualified for this level of the training, had to have been successful at basic proficiency examination with a minimum of 70%. The training lasted for five days and participants were exposed to more in depth concepts in the field of urban pest management. The participants were also exposed to practical in field exercises. Sixteen of the 23 persons registered for the course graduated from the intermediate program. A graduating ceremony was held for all those who were successful in the Basic and Intermediate Proficiency Programs.

Education Program for Vendors of Pesticides and Toxic Chemicals

The PTCCB commenced its education program for vendors during the year in review. This program is a two year program and will be completed in 2015. The training sessions focused on sensitizing vendors on the responsible use and handling of pesticides, the proper transport, storage and disposal of pesticides and the importance of their role in advising farmers on products and product selection.

The course outline is as follows:

- 1. Introduction to Pesticides
- 2. Pesticides Legislation in Guyana
- 3. Pesticides labeling
- 4. Pesticides and Human Health and Environment Safety
- 5. Transportation, Display. Storage and Disposal
- 6. Pest Management

Fumigation Practices in Guyana

The practice of fumigation of rice and lumber using aluminium phosphide was examined by the Board to ensure proper use of the restricted use pesticide. As such meetings were convened with rice millers and rice exporters in Regions 2,3,4,5 and 6. The meetings focused on the way forward for fumigation in the rice industry and the accessibility and handling of aluminium phosphide tablets. The meetings agreed that only registered Pest Control Operators (PCOs) will be allowed to have access to the aluminium phosphide tablets and only PCOs shall be authorized to conduct fumigation exercises commencing in 2015. The meetings also brought out the need for pesticides awareness training for millers and rice exporters, which the PTCCB acceded to facilitate.

The Board also examined the capabilities of Pest Control Operators (PCOs) in executing fumigation exercises properly and effectively. The Chairman of the PTCCB, Dr. Leslie Munroe, highlighted the importance of safety when fumigation exercises are being conducted. It was identified that specialized fumigation training is needed for all Pest Control Operators. This shall be provided by the Board and conducted in early 2015.

Service Providers Training

The Pesticides and Toxic Chemicals Control Board conducted a three day training seminar for agriculture extension staff and other agricultural service providers. The seminar was held at the Regency Hotel and saw participants coming from all the regions in Guyana. The participants were exposed to a wide range of topics such as; safe use and handling of pesticides, transport, storage and disposal of pesticides, proper protective equipment, pesticides contamination, the tracer kit technology, labeling, pictograms, colour bands, human and environment exposure to pesticides, pesticide formulations, spray equipment care and management, pesticides mixing and calibration, integrated insect management and pest and disease management.

The specific objectives of this programme were as follows:

- To emphasize the risks associated with the indiscriminate use, storage, and handling of pesticides.
- To emphasize the dangers associated with prolonged unprotected exposure to pesticides.
- To emphasize the environmental and occupational hazards associated with the misuse of pesticides.
- To highlight Integrated Pest Management Strategies
- To highlight Pest and Disease Management Practices

Training was conducted through technical sessions, field practical demonstrations and utilization of microscopes and magnifiers for pest identification sessions.

Each Participant received the following:

- 1. USB Storage Drive uploaded with all PowerPoint presentations
- 2. Bains and Boodhoo Pesticides Booklet
- 3. Service Providers Training Manual (developed specifically for participants)
- 4. Pesticides Newsletter
- 5. Brochures on Chemical Storage, Disposal, Labelling, Application Techniques
- 6. Booklet of Registered Pesticides for Guyana

These were intended to further enhance the technical capacities of the Service Providers and to make available to them appropriate tools to enhance their ability to conduct activities for farmers.

Customs and Trade Administration and Chemicals Management

The Customs and Trade Administration of the Guyana Revenue Authority are an integral part of chemicals management with specific focus on transboundary movement of chemicals. The Board conducted pesticides awareness training for customs brokers from various ports of entry. The training focused on highlighting the importance of sound chemicals management, and also pointed out to the customs brokers the importance of their role in the process. In addition, information was presented on registered pesticides and those that are prohibited for use.

Training and Awareness for Farmers and Farm workers

A total of one thousand and twenty one (1021) farmers and farm workers were trained during the year under review.

The participants were trained on the following topics:

- Management of Pesticides in Guyana;
- Pesticides Act and Regulations:
- Benefits and Risks of Pesticides Use;
- Pesticides Classification;
- Pesticides Labeling;
- Safe Handling and Correct Use of Pesticides;
- Classification of Pest;
- Pest Control Measures and Practices:
- Dose Rates and Recommendations;
- MRLs; and
- Storage and Disposal of Pesticides.
- Safe application of household use pesticides

Public Awareness Materials were developed for distribution throughout the year such as newsletters, conversions handbooks, brochures on safety, storage and disposal of empty containers. Pamphlets for farmers, farm workers, pesticide users, pest control operators and general public. Participants of all training and awareness programmes received:

- Measuring cups
- PPE: gloves, respirators
- Farmers Conversion Handbook
- Newsletter
- Pamphlets on storage and use practices

Public awareness advisory messages on the prescribed use of aluminium phosphide tablets were done to highlight the dangers and its prohibited use.

4. National and Other Events

GUYEXPO

The Pesticides and Toxic Chemicals Control Board participated in GUYEXPO, 2014 which was held at the Sophia Exhibition Complex from the 2nd to the 5th of October.

The Board's display focused on the hazards of harvesting treated crops before the recommended post spray interval and using more than the recommended dosage. The display also drove home the message of the dangers of applying more than the label directed amount of the pesticides causing harvested crops to have higher than the allowed Maximum Residue Limit (MRL).

Agriculture Research Conference

The PTCCB participated in the Agriculture Research Conference (ARC) by attending its technical sessions and mounting a display featuring the dangers of using higher pesticide dosages than that recommended, and harvesting crops sprayed with pesticides before the post spray interval would have elapsed.

Pesticides Awareness Week, 2014

Pesticides Awareness Week was observed from the 26th October to 1st November, 2014 under the theme "Buy as required use before they expire". The Pesticides Board held a series of activities to commemorate the week. A message from the Minister launched the week of activities along with radio messages, television programmes, appearances on talk shows, infomercials and a three day training conference for agriculture extension staff and service providers.



5. Pesticides and Toxic Chemicals Laboratory

Formulated Laboratory

Qualitative analyses were successfully done on three formulations, viz Asulam, Hexazinone, and Metsulfuron methyl. Using CIPAC methods of analysis, 26, 23 and 18 successive runs respectively were done on the pesticide formulations to determine their percentage active ingredient

- a) Asulam
 - A total of 26 successive analytical runs were done to determine percentage active ingredient content of the product using CIPAC method for analysis.
- b) Hexazinone
 - A total of 23 successive analytical runs were done to determine percentage active ingredient content of the product using CIPAC method for analysis.
- c) Metsulfuron- methyl
 - A total of 18 successive analytical runs were done to determine percentage active ingredient content of the product using CIPAC method for analysis.

Residual Laboratory

The Residue Division carried out fifty-one (51) analyses on various samples both for Secretariat purposes and in-house capacity building in residue analysis.

Samples analyzed for 2,4 D residues were inconclusive since the pesticides was undetectable via GC-MS due to very low concentrations at time of analysis.

The laboratory was successful in analysis of several vegetables. These samples were spiked using pesticide standards. The methodology used resulted in detection of pesticides in the samples.

- a) Pak-Choi
- b) Cucumber
- c) Squash
- d) Ochro (Leaves)
- e) Plantain (Leaves)
- f) Green Beans
- g) Red Beans (Leaves)

Full scan methods were used to generate residue profiles for the samples. For each sample, triplicate analyses were done.

The laboratory explored analyzing other sample matrices via a modified AOAC Method 2007.1, such as rice, soil and meat. These commodities were all commercially available. These matrices caused some difficulty in analyzing due some limitations in the sample preparation.

The laboratory continues to work on residue analysis for the following active ingredients in fruits and vegetables:

Capacity Building for Laboratory Personnel

Staff received training on Pesticide Residue Analysis in food, instructed by Dr Evaldo de Armas which allowed staff to further their knowledge of the data processing parameters with respect to GC-MS instrumentation. The laboratory began networking with other residue labs regionally with the participation in the "Pesticides residues workshop" facilitated by the EU and hosted by the Dominican Republic.

Staff received Quality Management System (QMS) Training on: Understanding the Requirements of ISO/IEC 17025 Standard, Root Cause Analysis, Data Analysis and Laboratory Safety Requirements (GYS 235) hence, staff will contribute positively in establishing a QMS for the laboratory.

ACCOUNTS 2014

The Accounts for the Board for 2014 will be submitted to the Audit Office in keeping with Boards work plan. The Auditor General's Office shall examine the Board's Financial Statement for 2014, as required under Section 41 of the Pesticides and Toxic Chemicals Control Act and the Financial Management Act, and validated that the Financial Statements reflected fairly in all materials respects, that the financial position of the Board as at 31 December 2014.

BUDGET 2014

The proposed budget of the Board for the year 2015 reflects a total expenditure of One hundred and thirty million, five hundred and ninety three thousand dollars (\$130,593.00). This expenditure will be used for delivery of the Boards program and daily operations of the agency.

WEBSITE

The Board's Website, http://www.ptccb.org.gy was continuously updated during the year to make it more modern and user friendly and to ensure that all services of the Board are available to the public. The Board continued to use the website as a means of spreading messages and providing relevant information for the general public.

KEY ISSUES AND CHALLENGES

The key issues and challenges facing the Board continue to be the implementation of the Pesticides and Toxic Chemicals Regulations with respect to the following:

Secretariat of the Board

Infrastructure of the Secretariat/ Administration - The need for additional staffing is important to the execution of the Board's mandate. This is integral to management of toxic chemicals, restricted use pesticides, current chemical practices etc. However, the Board is constraint in engaging additional personnel due to lack of accommodation to house same.

Pesticides and Toxic Chemicals Laboratory

- **Supply of consumables** The process for the supply of consumables to the laboratory has proven to be very tedious, expensive and time consuming.
- **Infrastructure of PTCCB Laboratory** The current infrastructure is a major constraint for the certification of the Boards laboratory. In addition it is recommended that the formulated and residual laboratories be separate to avoided contamination and quality of results.
- **Equipment** Some active ingredients could not have been detected as some are undetectable via GC-MS while due to their very low concentrations others remained undetectable. Finding compatibility of standard test methods (CIPAC and AOAC) with equipment in time efficient manner.






Figure 2: Herbicides Imported for 2014





Figure 3: Insecticides Imported for 2014



Brodifacoum was the most imported rodenticides for the year in review with a total of 45,090kg being imported.




Figure 6: Import Licenses Issuance, 2014

FUTURE PLANS: 2015 ONWARDS

The Board aims to continue to strengthen chemicals management in Guyana in a lifecycle approach through great education and awareness programs and implementation of the Pesticides and Toxic Chemicals Control Regulations 2004 (No. 8 of 2004).

Projections 2015 PTCCB

- 1. Registration of 50 pesticides for import, sale and use in Guyana
 - Reduction of dangers associated with these products to human health and environment
- 2. Licensing of 2500 imports of pesticides and toxic chemicals
 - Approval of all chemicals imported, information gathering and availability as too quantities, names, types, targets pest etc.
- 3. Training and certification and Licensing of Pest Control Operators
 - Ensuring use of household pest control products, use of registered operators, reduce use of agricultural pesticides in household pest control
 - Ensuring capabilities and skills to carry out fumigation in Guyana
- 4. Licensing of 180 pesticide vendors countrywide
 - Ensures availability of registered pesticides to farmers
- 5. Training and awareness programmes reaching 1500 farmers and farm hands
- 6. Increase public awareness via newspaper, inews, website, newsletter
 - Benefit decrease in illegal trade and vending of household and agri. pesticides
- 7. Training of Extension agents and students from the Guyana School of Agriculture
- 8. Execute investigations relative to the mis-use of pesticides
- 9. Training provided on the following area:
 - Safe and Effective Use of Pesticides
 - Disposal and storage in Pesticides
- 10. Analytical works by the laboratory to support the Board
 - The Pesticide Laboratory supports the Board in ensuring food safety in agriculture production
 - Verifies quality and types of pesticides used in agriculture
 - Verification of maximum residual limits
 - Instituting programmes to allow accreditation
- 11. Build staff capacity through international participation and training
 - Inspectorate training on inspection and enforcement
 - Obsolete and bio pesticides
 - Laboratory analysis of formulated products
 - **Residual Analysis**

12. Training and awareness to Customs and Trade Administration to strengthen enforcement and reduce Transboundary movement of chemicals, reduce illegal imports
